

# HWT 2008 GUN FUNDRAISER

## FUNDRAISER RULES

### SPONSOR:

This fundraiser is sponsored by Hi-Way Tabernacle, 108 County Road 2250; Cleveland, TX (a Texas non-profit organization and hereafter will be referred to as "the Church") and conducted by the Church Pastor and Official Board (hereafter will be referred to as "the Committee"). The following are the Fundraiser Rules approved by the Committee. These rules will be adhered to by all participants of this drawing. By making a donation and receiving a ticket, participants agree to be bound by these rules as stipulated and will not dispute or challenge these rules and regulations in any court of law.

### Eligibility:

Participants of the drawing must be 18 years of age or older. The minimum requirement for participation is one ticket obtained by a donation of \$25.00 to Hi-Way Tabernacle.

### A. Rules of Drawing

A1. Only one individual may be identified as the purchaser of the ticket.

A2. There is no limit on the number of tickets that any particular individual or entity may purchase.

A3. Only those valid ticket stubs containing the participant's name, address and telephone number will be eligible for drawing.

A4. The tickets will be valid for the drawing only after the participant's payment is honored and is paid by his/her bank.

A5. Only valid tickets sold on or before July 3, 2008 are eligible for drawing.

A6. Hi-Way Tabernacle of Cleveland, TX is not responsible for any illegible or erroneous information written on the ticket stub.

A7. 350 tickets or more must be sold by the deadline date for drawing to take place. In the event that less than 350 tickets are sold, Hi-Way Tabernacle will be responsible to inform all ticket holders using the information provided on the ticket stub that the minimum amount of ticket sales was not met. Every ticket holder will be eligible for a refund of the ticket price. The option to donate the amount to Hi-Way Tabernacle will be offered. If the option to donate is taken, a tax-deductible receipt will be issued. Hi-Way Tabernacle will make every attempt to contact ticket holders before July 31, 2008. After July 31, 2008, if, for whatever reason, Hi-Way Tabernacle is unable to contact the ticket holder, the ticket price of \$25.00 will be considered a tax-deductible donation.

A8. The decisions taken by the Committee will be final for any disputes in connection with this drawing and those decisions cannot be challenged in any court of law for this matter.

A9. The Committee reserves the right to postpone this drawing or change the closing of the raffle ticket sale in the event of any unavoidable or unforeseen circumstances.

B. Selection of the Winner and the Procedure for Claiming the Prize.

B1. The winner of this drawing will be determined by a random drawing which will be held on July 4, 2008, 12 o'clock noon at the Church—108 County Road 2250; Cleveland, TX.

B2. The Committee will be responsible for conducting this drawing.

B3. The results of the drawing published by the Committee will be final and cannot be challenged in any court of law.

B4. Once the prize is awarded to the winner, the decision is final. No alternate prizes will be given.

B5. The ticket holder does not have to be present during the drawing. If the winner is not present at the drawing, the Committee will notify the winner of the drawing either by phone, e-mail or postal mail.

B6. The winner must present the original winning ticket with a valid proof of identification (Driver's License / valid Passport / Texas Identification Card) in order to claim the prize.

B7. In the event of any dispute or controversy regarding the identification of the winner, the winner will be required to produce the required additional information as requested by the Committee.

B8. Reasonable attempts will be made by the Committee to contact the winner through the address, phone number and e-mail address provided on the ticket stub. If the winner of this drawing could not be contacted after reasonable attempts by the Committee or the winner fails to claim the prize within 14 days of the drawing date, the Committee will conduct a second drawing to determine a winner. The same procedures for claiming the prize will apply.

B9. All net proceeds of this drawing will go toward the Church fund.

B10. The Committee has the right to amend the rules as deemed necessary to ensure a successful fund-raising effort.
